Letter from the Chair

The 2007 convention in St. Louis is fast approaching: the convention opens with the annual RCA WSO business meeting on Friday, August 3, 2007. This will be the first year of the new delegate structure and delegate voting in accordance with the bylaw changes adopted by the Fellowship last August in Boston. Much work remains to be done to get all of the details into place for our first delegate-based business meeting on Friday and our first delegate-based elections on Sunday morning of the convention. The Board of Trustees will need and greatly appreciate the patience, tolerance, cooperation, support, and prayers of all of the RCA member groups as we work together through all the details of this new process, a process intended to give all member groups a greater voice in determining the scope of the services provided to, and in the name of, the RCA fellowship by the World Service Organization. Of course, we must never forget to place our ultimate reliance in our Higher Power and to remember to let nothing come in the way of our own continued recovery as individuals and as couples.

There are a number of matters that each member group may wish to consider in the coming days and weeks leading up to the convention:

Delegate Couple Voting

The time has come for each RCA member group to begin the process of selecting a delegate couple to represent your group at the RCA 2007 Convention in St. Louis. At the 2006 convention in Boston, the fellowship voted to implement delegate voting to begin at the RCA 2007 convention.

The major objective of the change to delegate voting was to get broader representation from the fellowship in all matters voted on at the annual convention. As stated in the amended bylaws the purpose is "[t]o ensure that the services provided by the W.S.O. are guided by the collective group conscience of the entire membership." Prior to the 2007 convention, all voting was by those RCA members present at the convention. Many RCA members felt that the bylaws should be changed to try to include the views of those member groups that were unable to have a member couple in attendance at the convention.

Letter from the Chair page 1

Matters the Fellowship Wishes to have addressed at the Business Meeting:

While our Structure Committee is working on a number of matters to be considered at our annual business meeting, the fellowship has also been asked to identify any matters that the Member Groups may wish to have voted on at the meeting. Each member group should have previously received notice of this from the WSO to their GCC and also from the Outreach Committee. A copy of that notice is posted on the RCA website.

The Delegate Couple for Your Group: Each member group has been asked to make an initial designation of their delegate couple and provide that information to the WSO by 15 May 2007. The notice on this matter is also posted on the website. Please remember that any group unable to have a delegate couple attend the convention will still need their designated delegate couple to submit their group’s by-mail ballot for matters to be considered at the business meeting.

Items that Each Group Should Make Plans to Consider:

By May 5, each group should receive a list of the topics that will be considered at the business meeting and for which by-mail voting will be provided. Soon after June 4, each group should receive the wording, in terms of motions, for the matters to be considered at the business meeting. Groups may wish to establish their collective group conscience on all of these matters so that they may provide guidance to their delegate couples. Those groups voting by mail will need to submit their ballots in accordance with the deadlines and procedures that will be established.

Preparation by Delegate Couples Attending the Business Meeting:

The first job of the delegate couples attending the business meeting will be to approve the standing rules that will govern the conduct of the meeting as well as the agenda for the meeting. The Structure Committee will be working on the proposed rules and a proposed agenda for submission to the delegate couples prior to the convention. Since the business meeting on August 3 will be an all-day meeting (approximately 9:00 am to 5:00 pm), delegate couples coming to the convention from out of town might want to consider arriving in St. Louis on Thursday, August 2.

Comments on the 2006 draft of the Fourth Editions of the Blue Book:

Please also remember that the comment period has been extended through the closing day of the convention, August 5, 2007. Please check the website for the notice and other materials relative to providing your comments on the 2006 draft.

That path can be narrow or wide, uphill, downhill, or flat, like the struggles in our coupleship. If we are moving along that path, we are moving away from brokenness. Checking in with another couple to listen to their journey will remind us of places we have been before as a couple. Our experience, strength, and hope are meant to be shared. It is vital to our couple recovery to continue doing a 12th step.

Sponsorship is a great way for a coupleship to grow and flourish as we share our walk down the path of life with others.

Thus, as part of the new delegate-voting structure, the bylaws were amended to include by-mail voting and proxy voting so as to give a voice to those member groups that would be unable to have a member couple in attendance at the convention.

We all hope that each member group will be able to have a delegate couple actually attend the 2007 convention in St. Louis, **your group will need to designate a delegate couple even if your group will not have a member couple in attendance at the convention.** For a group not having a member couple in attendance at the convention, under the amended bylaws, it will be the responsibility of your group's delegate couple to submit the by-mail voting ballot from your group.

In addition to by-mail voting, the amended bylaws provide for proxy voting. Thus, if your group will not have a member couple in attendance at the convention, you will also be able to designate a delegate couple from another member group to vote for your group at the convention by proxy.

However, the amended bylaws do include a major limitation on proxy voting: a delegate couple in attendance at the convention may hold only one proxy.

To begin the process of identifying the delegate couples, each member group is asked to notify the WSO office, by e-mail wso-rca@pacbell.net or by letter to WSO, P.O. Box 11029, Oakland, CA 94611), of the **identity of your delegate couple and whether you expect that member couple to attend the 2007 convention in St. Louis**, 3 through 5 August 2007. Please provide both the e-mail addresses and the phone numbers for your delegate couple.

Please provide the initial designation not later than 15 May 2007. You will be able to update your designation later if your group finds that necessary. Your group may also designate an alternate delegate couple if your group wishes.

It Was a White Wedding

It was a white wedding, fluidly flowing into a post-mortem reception. Eating. Dancing. Toasting. Waving goodbye. Off to never-never land in a rented limousine. Gawkers saw the car and wondered, "Who is behind those darkened windows? A celebrity? A prom couple? Newlyweds?" I always looked at limos and thought, whoever they are, their life must be whole lot more exciting than mine.

Marriage is always presented as that fantasyland. That is where the story ends in most movies and books. But is it really the end of a fairytale, or the beginning of something else? Let me take you through a secret door, past the fantasy on the book jacket. The fairytale is just the beginning, and not always pie in the sky. Come with me, to see what happens after the reception:

I feel like a princess in my long, off-white gown. I have envisioned this day for months, longed and wondered about it throughout my life. We get out of the limo, walk through the lobby of the hotel, and total strangers stare at us, and congratulate us. I feel some sense of envy, wonder and awe in their faces. What a great day.

We go to the room. It is very nice, not too big, but with the essentials --- a great big bed. We want to rest before...before what? We have to leave very early in the morning to catch our flight to Cancun. My new husband helps me out of my dress; we get into our swimsuits and go to the pool. Oh, it's so relaxing. My muscles are sore and tired from a week of finishing last minute details and activities. I don't mess up my hair.

We go back to our room. We are starved because there has been no time to eat all day. While I wait for the food, my new husband goes downstairs, "for a minute." He is gone for several hours. The food comes, but I don't eat. I'm too angry. I know where he is. At the bar. Getting drunk. On our wedding night! My blood boils. I feel angry, humiliated, and disappointed.

This wasn't the fairytale ending I had envisioned. So what did I do? I wallowed in my pity, anger, and frustration. I added it to my file of why he was a terrible husband. I hated myself because if he loved me this would not have happened. If I was more beautiful...thinner... better... he would want to be there with me and make love because I was the best, most wonderful wife in the world.

I started my rant when he came into the room, or rather stumbled into the room. Screaming. Blaming. Attacking. "How dare you do this to me! I hate you! I want an annulment!"

He passed out on the bed, and I was left to stew in my juices. I called my mother, crying and wailing, "I'm not going on the honeymoon. I want an annulment."

His whole family was staying at my parents' house. So

they all knew how upset I was. They also knew he must not really love me, and this was a horrible mistake, etc., etc., etc.

My parents came to pick us up the next morning and take us to the airport. When they arrived we were packed and ready to go. When they asked if we were still going I answered, "Of course."

Now, after years in couples recovery and individual recovery, I am able to re-write this story, and accept my responsibility in all this. If I knew then what I know now, I could have handled it differently.

Come with me again, to what could have happened after we left the reception.

I feel like a princess in my long, off-white gown. We walk through the lobby of the hotel and total strangers congratulate us, stare at us. What a great day.

We go to the room. My new husband helps me out of my dress, and we get into our swimsuits and go to the pool. Oh, it's so relaxing. We go back to our room. We are starved, and while we wait for the food, my new husband goes downstairs, "for a minute."

When he does not come back for awhile, I go downstairs to check on him (these days I would call him on the cell). I hear the slur in his voice, and I realize I have a decision to make. I can relax in the room, watch a great movie, and eat a fabulous dinner. I am not happy about his choice, but I am not going to let this mar what has been a beautiful day by "shoulding" all over him. I may even go down in my long robe with my new negligee under it, and flash him at the bar and say, "I hope I don't have to wait until tomorrow." I could even have a drink or hors d'oeuvres with him.

In terms of calling my family - what the hell am I calling them for? I should be relaxing and enjoying myself. We have a week in Cancun to share all the decadence, and explore each other and new things. What he chooses to do has nothing to do with how pretty I am, how thin (or fat) I am, or how wonderful or terrible I am. Yes, I am disappointed, but it is not the end of the world.

In actuality I made things worse by having a catastrophic reaction to an ongoing, unresolvable, issue. I brought in the big guns (guilt, my parents, threats, expectations, judgments) to make him stop doing what I felt he was doing to me. I have since learned that people can get drunk and have fun anyway. Of course for me it was all or nothing. You are a drunk or you are sober. This marriage was brand new, and we both turned to our addictions: alcohol, food, and emotionality. At that very moment, my outrage was destructive. It damaged me, my spouse, and the relationship between us and our respective families. Of course, drinking has its issues, but those are not MY issues to fix or share. I can't take his inventory. I can only take mine.

Now, 10 years later we are still married, only by the grace of God, and the love and peace of the RCA program. Keep coming back; it works if you work it.

Our Story

February 19, 2005 found Dan and I traveling to a local Church to hear a respected speaker and author, Christopher West, talk about love and marriage. We were among approximately 350 others of all ages listening to him describe how we are all searching for God's love, ultimately, but find ourselves "dumpster diving" by using pornography, lust, and adultery in our confusion about what "real" love is in this world.

About half way through the eight-hour seminar, Dan disclosed to me that he had a problem with pornography. We had been married more than 30 years and it was very hard to comprehend what he was telling me in that moment. Dan was diagnosed shortly after with sexual addiction and voyeurism. He went to Patrick Carnes' Gentle Path Program in Hattiesburg, Mississippi, for six weeks. I joined him for family week. True agony describes my feeling of betrayal and loss of the person I thought I had been married to all those years. Our journey over the two years since then has been the most painful, but truthful, period of our lives. We were separated for a period of time, trying to discern who we were and whether we could ever make sense of all that had happened. Intense counseling, both individually and as a couple, RCA, individual 12 step recovery programs, working the steps, doing inner child work, etc. brings us to today.

We are still married and have begun to rebuild our life together. We try each and every day to be as honest, respectful and loving as possible. It is such a relief to know we don't have to do this perfectly. Our Higher Power assures us that if we just keep trying, He so loves us for that and will continue to give us the graces to keep moving forward. We are better at recognizing issues between us and we are better equipped to discuss and deal with them, rather than pretend they don't exist. We are better at telling each other how we feel, especially when we are angry or sad, rather than suppressing how we feel and pretending everything is OK. It still is very hard at times, but it is more honest and we know that makes it better. We also know that the hard work, time, effort, and money we are putting into recovery can never be measured in the reward of finding our "true" selves. We are grateful to each other for the commitment and hard work we have put into recovery, and our gratitude to all those professionals and peers from our 12 step programs will forever be such a precious part of our lives.

We are looking forward to sharing and growing with other couples at the convention in St. Louis in August.

Fellowship, Hawaiian Style

In our two Hawaii RCA groups we have a lot of fellowship. After each meeting, we go out to dinner together. This practice started when there were only two or three couples regularly attending the first RCA meeting in Hawaii. These early couples had time in AA and other 12-step programs, so there is a lot of recovery in our meetings, and it adds to the emphasis on fellowship. We even foster fellowship in our monthly business meetings by making it a regular potluck dinner.

Gradually, word has gotten out about this great program, mostly through AA shares and contacts, and the fellowship has grown. Couples have started coming that have no twelve-step background. They add much to our meetings and fellowship; they make our language and outlook more inclusive, giving RCA a wider appeal to couples and families we might help.

The second Hawaii meeting grew directly out of the first. It is located about 20 miles away from the first meeting, and many RCA couples attend both. We keep this second meeting an open meeting, for singles and couples alike, so that we can spread the RCA message to those people who are between coupleships. We have found that many people have given up on being in a coupleship, experiencing it as so painful that loneliness becomes the lesser of two evils. After visiting our open RCA meeting on Saturday nights, many of these singles go away hopeful that if and when they meet someone with whom coupleship appears possible, they will have the tools of RCA to break the dysfunctional patterns that have plagued them before.

Again, at these Saturday night meetings, both couples and singles are welcome to dinner afterward. We have a great time together. We become more like family each and every day. This fellowship bond helps all of us recover and makes RCA meetings a fun time we all look forward to.

Please send in your feedback on the 2006 draft by Aug.5th or sooner. Consider going to the RCA website and downloading the side-by-side presentation of the 12 steps as written in 1996 vs. 2006. It could be the starting point for your group's feedback.

Speaking of St. Louis...

August is right around the corner, and as one of the co-chairs for the 2007 RCA annual convention, I have been looking at hotels and menus for over a year! We have tried to make the meals as healthy as possible, taking into consideration food addictions, sugar-free needs, and various dietary issues. We have discussed this with the hotel personnel, and they are aware of our various dietary needs. Feel free to request an emailed copy of the planned meals from me if you are concerned about purchasing a meal packet.

The Business meeting will begin on Friday morning in the Penthouse Ballroom, 9 am until 5 pm. Room check-in is 3 pm. There will also be a "Welcome RCA" reception at 3 PM in the hospitality room (Presidential Suite) on the 11th floor.

As a 12 step program, we feel a good way to begin a convention is with the steps, and we will have a Speakers Panel on the first three steps on Friday evening, then one break-out session, followed by a social get-together in the hotel's ballroom. It is up high, with large glass windows and you can watch planes landing at the airport. There is plenty of room to sit and talk, or dance. There is no planned meal Friday evening, and we will be on our own for dinner. There are plenty of take-out places and restaurants within walking distance. There will be other step-panel meetings at meal times throughout the weekend.

Speakers! We need speaker couples at the convention. The theme is Intimacy and Healthy Sexuality, and you don't need to be experts. The best speakers come from the heart, and share their experience, strength, and hope.

Besides the step-panels, some of the topics for the breakouts will be: health issues and intimacy and healthy sexuality; dealing with finances and its affect on intimacy; balancing work, family time, and intimacy, and finding time for romance; what is intimacy: discussing the differences between physical sex and healthy, intimate sexuality, and what is non-sexual intimacy; how does spirituality fit into our coupleship; how do our religious beliefs impact our coupleship; does having children affect couple intimacy and sexuality?

There will also be a generational breakout group. My parents were in recovery until they died, and Scott's mom and stepfather attend recovery programs. Our daughter and her husband are also in recovery, and the

"Important Dates to Remember"

Apr 21, 2007 Member Groups must provide WSO with a list of any topic that they want to be voted on at the RCA business meeting on 3 August 2007.

May 1, 2007 Final list of topics to be addressed at RCA business meeting must be prepared and ready for transmission to the GCC's. This is necessary so that by-mail voting will be available for all these matters. Under the bylaw changes adopted at the 2006 convention, 90 days notice must be provided for any matter for by-mail voting.

May 5, 2007 This date is 90 Days prior to RCA Business Meeting of 3 August 2007.
